UNREGULATED SOCIETY-KEY TO GOVERNANCE

Ideally in an utopian society, all the affairs pertaining to people are well articulated through defined laws. Subsequently rights, limitations and responsibilities are well known by all, through two key factors; education and punishment. Primarily all means are used to educate masses about prevailing laws. Those who fail to be educated due any reason are taught through requisite punishments, either as recipients or witnesses. Thus with a passage of time law abiding, fear of law, consciousness about law, awareness....whatever we call it, becomes deep rooted in the society and subsequently reflect. Such societies are generally called educated, developed, advanced, etc.

Despite education being the cornerstone of such societies, in my opinion punishment or fear of being caught and punished for wrongdoings actually maintains the initially achieved level. For instance according to Oxford dictionary, education is defined as

"The process of receiving or giving systematic instruction, especially at a school or university"

If education means teaching something which is not known then do we think people don't know that stealing is wrong? And yet there are thieves around the globe. Yet there are more thieves where the deterrence of law is less and simultaneously there are fewer thieves where rule of law is more pronounced.

Thus in order to maintain a society to its best, after education, law enforcement is the most instrumental factor. The same is done through LEAs (Law enforcement Agencies) which ensure that people abiding law are protected and those violating are dealt accordingly. Most importantly a society cannot be left on its own as it has to be managed, controlled or regulated. The most pronounce factor is that people are not at liberty to deal such societal matters on their own, which involve legal aspects. For instance, in developed countries a routine road accident is never directly/ solely dealt with persons involved in the accident, unless suitable LEA rep takes charge and regulates the matter according to prevailing law. Such societies not only keep the populace under the law, but a majority of upper/ influential class is also duly regulated. In that mocking of law by strong, of law breaking due influence remain isolated and the state does not allow everyone to enjoy such liberty, as it remains extremely limited and to

an extent latent. As a result, people have the time, energy, education, courage and means to monitor/ challenge the state, which also keep the state under pressure to a certain extent.

And for that very reason, there has to be intervention of the state to ensure through strict regulation.

Thus if anyone has to take charge and call shots, then it has to be the state apparatus. Unfortunately, there appears no formula other than top-down approach. Bottom-up approach can only create feeble ripples, disheartened failures and perhaps more gloomy society. So as individuals, besides abiding by law, state has to be forced to recover from paralysis and start regulating. The same may only be possible if the people at the helm of the affairs are touched to trigger the dormant capability to deliver goodness. Perhaps pressure groups within segments of society can create awareness to aware the state. Or perhaps someday divine intervention may trigger a change.
